Conference App Exhibitor Passport Feature

The Exhibitor Passport is an interactive feature designed to increase exhibitor visibility and attendee engagement by encouraging attendees to visit exhibitor booths. This program helps exhibitors drive booth traffic, generate qualified leads, and create more meaningful interactions with conference participants.

The Passport operates as a digital or physical “scavenger hunt,” where attendees collect stamps or check-ins from participating exhibitors to qualify for prizes or incentives. As part of the contract for exhibit space, exhibitors agree that any booth gifts, prizes, take-aways, or promotional items provided to Annual Conference attendees may not exceed a value of \$25 per item.

Cancellation Policy

Cancellations for exhibit space and/or conference registration before Tuesday, September 1, 2026 will be charged a **\$50.00 service fee**. No Refunds issued, for cancellations or no-shows, after September 1, 2026. Advanced payment required in order to participate.
