With Cybercrimes on the Rise, Be Extra Vigilant in Overseeing the Public

It looked like a routine, straightforward email message from a school superintendent, requesting payment for a bill. An official-looking invoice, describing alleged services provided, was produced to justify the electronic cash transfer.

But something sounded fishy – there was no purchase order on file, and the email sender asked that the funds be taken from an "offset account," which didn't exist. A quick check with the actual superintendent confirmed that the email was fraudulent, and this particular school district avoided being scammed.

Other public offices have not been so fortunate. The increase in these so-called spearphishing attacks prompted me earlier this year to issue an alert (https://ohioauditor.gov/publications/docs/Cybersecurity_Advisory.pdf) urging state and local government employees to be extra vigilant when reviewing requests to redirect payments from public accounts.

Cybercrooks will stop at nothing to get their hands into the public coffers. We need to do everything possible to ensure those resources are available for roads and schools, police and firefighters, and other services the public relies on, not padding criminals' pocketbooks.


Whether it's building a new housing development, remodeling an aging business park, or landing a high-profile headquarters, there's certainly a lot one needs to know. And the impact these projects can

GFOA Mini Stress Test for Local Government Budgets

GFOA is offering a simple do-it-yourself demonstration created with the tools from ProbabilityManagement.org. This mini-stress test demonstration addresses the risk of running a budget

deficit. You enter your revenue forecast, including estimates of the potential error in your forecast. No forecast will ever be exactly right and can sometimes be quite wrong – the potential error in the forecast presents a risk that revenues will be insufficient to cover

planned spending. You can estimate the potential error by looking at the difference between past forecasts and what actually happened. You could also apply your professional judgment to estimate the range of possible outcomes. Given the potential error in your forecast, the model tells you:

- The chance you will run a deficit or a surplus
- The average size of the deficit or surplus you can expect
- If you are unhappy with your chance of a deficit, given your spending plan, the model tells you the size of the budget you can have in order to incur a level of risk you are comfortable with
