#### Addressing Concerns in the \$4 Billion Unemployment Mess By: Keith Faber, Ohio Auditor of State



Ohio's unemployment system is broken and failed us in a time of need, but help is on the way.

Thousands of people have had fraudulent unemployment benefits claims submitted with their identity. I also had an unemployment claim made in my name, which I know I didn't file because as an elected official, I'm not eligible for unemployment compensation. The situation has gotten so bad that my office was called upon by state lawmakers to

conduct a performance audit of the unemployment system. Additionally, I launched an audit to look at fraud within the system. What we found is rampant fraud and failure on multiple levels in Ohio's unemployment system.

These fraudulent unemployment claims and overpayments are estimated to have cost Ohio over \$3.8 billion- \$475 million in fraud and \$3.3 billion in overpayments and the number keeps growing. The money that has been paid out for these fraudulent claims is unlikely to be recovered, especially the funds we speculate went out of country to places like China or North Korea.

#### **IRS Announces Changes to Form 8038-CP Coming in January 2022** By: William T. Conard II, Bricker & Eckler



On November 16, 2021, the Internal Revenue Service (IRS) publicly previewed a draft of a revised Form 8038-CP (Return for Credit Payments to Issuers of Qualified Bonds), along with updated filing instructions and a new schedule that will impact some issuers starting in January 2022.

The form is used by issuers of qualified bonds to receive a credit. The credit amount, equal to a percentage of interest paid, varies depending on the type of bond. The form must be filed between 45 to 90 days prior to the relevant interest payment date. The new form must be filed for due dates after January 1, 2022.

### New Advisory Opinion!

At its November 10, 2021 meeting, the Ohio Ethics Commission issued formal Advisory Opinion 2021- 02, which addresses the question of whether a member of a legislative body of a local governmental entity can vote to elect himself or herself to serve as presiding officer of the

public entity, such as a city council. The question arose since in many situations, serving as a presiding officer results in additional payments for increased duties in a leadership role.
